MISSION

The Mahoning Valley Community School will provide a safe, structured and supportive learning environment for "at-risk" and/or drop out students. Students will have the opportunity to recover academic credit and explore educational interests while developing vocational skills.

VISION

It is our belief that all students will learn through innovative practice, structured discipline and school, family and community support. As an outcome, our students will pursue self-determined goals and will experience academic achievement.



The Mahoning County High School (Mahoning Valley Community School) is a community school established under Chapter 3314. of the Revised Code. The school is a public school and students enrolled in and attending the school are required to take achievement tests and other examinations prescribed by law. In addition, there may be other requirements for students at the school that are prescribed by law. Students who have been excused from the compulsory attendance law for the purpose of home education as defined by the Administrative Code shall no longer be excused for that purpose upon their enrollment in a community school. GIVING STUDENTS ANOTHER CHANCE

The Mahoning Valley Community School

The Story: The school was founded by Judge Theresa Dellick, through her recognition that students with court involvement were often suspended or expelled from their home schools and were left out of educational opportunities. This frequently allowed for students to become more involved in delinquent activities and they lost hope of ever completing a high school education.

The Mahoning County Juvenile Court formed a partnership with the Mahoning County Educational Service Center and the Mahoning Valley Community School was founded in 2008. MVCS provides an education based on positive behavioral supports, rehabilitation, and restorative justice. Students are grouped by grade level, all having the opportunity to participate in academic credit recovery to achieve their natural grade levels.



SERVING SPECIAL POPULATIONS

- ◆ Students suspended or expelled from their home school
- ♦ Students on probation from the Juvenile Justice Center served through Education Court
- ♦ Students in jeopardy of not graduating from high school due to delinquency or truancy
- ◆ Students who are credit deficient and behind in grade level
- ♦ Students who have dropped out and desire to return for a standard diploma

A message from the Ohio Department of Education, Office of Ohio School Sponsorship

Ohio Revised Code (ORC)3314.03(D)(2) specifies that the sponsor of school the must "monitor and evaluate the academic and fiscal performance and the organization and operation of the community school on at least an annual basis."

All Ohio community school sponsors must evaluate each school and submit a written report of school academic,

financial, organizational performance, and legal compliance to the Ohio Department of Education and make the report available to the parents of students enrolled in the community school.

The Ohio Department of Education, Office of Ohio School Sponsorship evaluates its sponsored schools on the performance of Ohio School Report Card indicators and on performance measures as listed in the school's community school Contract. It is noted that the Ohio School Report Card data is not available for this school year due to the Coronavirus State of Emergency Order as declared by Ohio's Governor, Mike Dewine.

The Office of Ohio School Sponsorship monitors the performance of its sponsored community schools through attendance at governing board meetings, on-site visits and through review of compliance assessments, monthly financial reports, and other reports related to the school's academic, financial and operational performance to ensure compliance with rule and law.




